The Offshore Fund individually beneficially owns 248,057 shares of Common Stock.

BH Management beneficially owns the shares of Common Stock owned by the Domestic Fund, QP Fund and Offshore Fund.

Mr. Chappell is deemed to beneficially own the 1,151,613 shares of Common Stock beneficially owned by BH Management.

Collectively, the Reporting Persons beneficially own 1,151,613 shares of Common Stock.

4(b) Percent of Class:

Domestic Fund individually beneficially owns 686,823 shares of Common Stock representing 3.4% of the outstanding Common Stock.

QP Fund individually beneficially owns 216,733 shares of Common Stock representing 1.1% of the outstanding Common Stock.

Offshore Fund individually beneficially owns 248,057 shares of Common Stock representing 1.2% of the outstanding Common Stock.

BH Management beneficially owns 1,151,613 shares of Common Stock owned by the Domestic Fund, QP Fund and the Offshore Fund representing 5.6% of the outstanding Common Stock.
