- (1) On April 20, 2013, 2,888 shares of United Natural Foods, Inc. (the "Company") restricted stock units vested. Of these shares, the Company withheld 935 shares on April 20, 2012 to satisfy certain tax withholding obligations in connection with the vesting. Includes 290 shares of common stock allocated to the reporting person under the United Natural Foods, Inc. Employee Stock Ownership Plan and 296 shares of common stock allocated to the reporting person under the United Natural Foods, Inc. 401(k) Plan's UNFI Stock Fund as of April 22, 2013.
- (2) Each restricted stock unit represents the right to receive one share of United Natural Foods, Inc. common stock upon vesting in accordance with the terms of Mr. Traficanti's restricted stock unit award agreement.
- (3) The restricted stock units vest in four equal annual installments beginning on April 20, 2010, the first anniversary of the date of grant.
