ITEM 7.01. REGULATION FD DISCLOSURE

On July 20, 2016 Dick's Sporting Goods, Inc. (the "Company") completed its purchase of The Sports Authority's ("TSA") intellectual property assets and the right to acquire 31 store leases, as previously described in the Form 8-K filed by the Company on June 30, 2016. The Company's rights with respect to the store leases allow the Company a period of time to determine whether it will accept or reject any particular store lease, thus providing the Company time and optionality to determine which TSA store locations it will ultimately assume.
