The Registrant is unable to timely file its report on Form 10-K for the fiscal year ended December 31, 2004 without unreasonable effort or expense. As previously announced, Stonefield Josephson Inc. (Stonefield) was engaged as the Registrant s new independent auditors on May 21, 2004. Since that time, the Registrant and Stonefield have completed a full audit of the consolidated financial statements for the three years ended December 31, 2001, 2002, and 2003, as well as reviews of the consolidated financial statements for the quarters ended March 31, June 30, and September 30, 2004. Given the non-stop pace of comprehensively auditing and reviewing these periods, as well as performing the audit for the year ended December 31, 2004, senior management was unable to hold all required meetings with its auditors and complete all necessary work, including documentation over internal controls required under Section 404 of the Sarbane Oxley Act, to finish the Form 10-K prior to the March 16, 2005 deadline.

The Registrant expects to file its Form 10K within the prescribed extended period of March 31, 2005.
