- (1) Series A-1 Common Stock is mandatorily convertible into common stock immediately prior to the closing of an IPO, a Qualified IPO, a Deemed Liquidation Event or the Put, each as defined in the Issuer's Amended and Restated Certificate of Incorporation.
- (2) There is no expiration date. The Series A-1 Common Stock converts into common stock on a 3.57-for-1 basis effective upon the closing of the Issuer's initial public offering.  
  
15,000 of such shares lapse annually in equal installments, beginning on June 8, 2006 and ending on June 8, 2010. The Issuer's repurchase rights with respect to an additional 10,000 of such shares lapse annually in equal installments, beginning on August 12, 2006 and ending on August 12, 2010. In addition, any unvested shares of restricted stock shall become vested immediately upon a sale of the Issuer or substantially all of the Issuer's assets.
