Bally Technologies, Inc. (the Company) hereby requests an extension of time to file its Annual Report on Form 10-K for the fiscal year ended June 30, 2007 (the 2007 10-K). The Company dedicated significant resources towards the preparation and filing of its Quarterly Reports on Form 10-Q for the fiscal quarters ended September 30, 2006 and December 31, 2006, which were filed on June 20, 2007 (the Form 10-Qs). As a result of the delay in filing the Form 10-Qs, the Company required additional time to complete its Quarterly Report on Form 10-Q for the fiscal quarter ended March 31, 2007 (the Third Quarter 10-Q), and as a result has been delayed in completing its 2007 10-K. Until the Company has filed its Third Quarter 10-Q, it will not be able to file its 2007 10-K. The Company continues to dedicate significant resources to the preparation of the Third Quarter 10-Q, the 2007 10-K and the related financial statements.

In its Annual Report on Form 10-K for the fiscal year ended June 30, 2006, filed on March 15, 2007, the Company reported a loss from continuing operations of \$(47.2) million, or \$(0.90) per diluted share, on revenues of \$547.1 million for the year ended June 30, 2006. As previously disclosed, the Company expects to report net income for the year ended June 30, 2007, as compared to the reported net loss in the corresponding period of the prior year, with diluted earnings per share exceeding \$0.34 on revenues of \$670 to \$690 million.
