(CF) issued a press release announcing that it has extended the expiration date of its exchange offer (the Offer) for all of the outstanding shares of Terra Industries Inc. to Friday, August 7, 2009. The Offer, which was scheduled to expire at 5:00 p.m., Eastern time, on Friday, July 10, 2009, has been extended until 5:00 p.m., Eastern time, Friday, August 7, 2009, unless further extended. All other terms and conditions of the Offer remain unchanged. CF also announced that on July 6, 2009, it filed a certification with the United States Federal Trade Commission (FTC) that CF has substantially complied with the FTC 's request for additional information in connection with the Offer.
