These shares include the following Restricted Stock Units (RSUs) granted under the Company's Amended and Restated 1991 Equity Incentive Plan: 5,000 RSUs which vests in two equal annual installments of 2,500 each commencing 7/31/2010; 2,529 RSUs which vest (1) in three equal annual installments of 843 each commencing 4/29/2010; and 5,700 RSUs which vests in four equal annual installments of 1,425 each commencing 4/29/2010. Vested RSUs will be paid in shares of the Company's common stock on a one-to-one basis unless payment is otherwise deferred by the reporting person.

(2) These are shares acquired under the Company's 401(k) Plan and represent interests in the Company's stock fund as of this filing.
