(1) Performance Enhancement Plan III ("LTPEPIII"), for net of 11,577 shares of Sunoco, Inc. common stock issued to reporting person (8,486 shares used for tax withholding obligation).

(2) Award of restricted common stock units pursuant to the Sunoco, Inc. LTPEPIII in a transaction exempt under Rule 16b-3.
