On January 31, 2007, TA will issue additional shares to HPT as a share dividend and HPT will immediately spin off all of its equity interests in TA to HPT's shareholders of record as of January 26, 2007. HPT shareholders will receive, at no additional cost, one common share of TA for every ten common shares of HPT owned as of January 26, 2007.
