This Amendment No. 2 (this "Amendment") amends, as set forth below, the statement on Schedule 13D, dated July 29, 2013 and filed with the SEC on August 1, 2013 (the "Original Schedule 13D"), as amended by Amendment No. 1 dated November 1, 2013 and filed with the SEC on November 1, 2013 ("Amendment No. 1"), for Bank of America Corporation ("BAC") and Banc of America Preferred Funding Corporation ("BAPFC" and together with BAC, the "Reporting Persons") with respect to the variable rate muni term preferred shares ("VMTP Shares") of Dreyfus Municipal Bond Infrastructure Fund, Inc. (the "Issuer" or the "Company"). This Amendment is being filed as a result of the amendment of the Registration Rights Agreement, dated July 29, 2013, between the Issuer and BAPFC, relating to the Reporting Persons' 750 Series W-7 VMTP Shares (CUSIP No. 26203D200) of the Issuer.
