#### ITEM 4.01: CHANGES IN REGISTRANT'S CERTIFYING ACCOUNTANT:

(a) On January 24, 2005, the Audit Committee of Solitron Devices, Inc. (the "Company"), decided not to re-engage Berkovits, Lago & Company, LLP ("BLC") as the independent certified public accountants of the Company.

BLC previously audited the Company's consolidated financial statements for the fiscal years ended February 29, 2004 and February 28, 2003. BLC reports on the consolidated financial statements of the Company for the fiscal years ended February 29, 2004 and February 28, 2003 did not contain an adverse opinion nor a disclaimer of opinion and were not qualified or modified as to uncertainty, audit scope or accounting principles.

In connection with its audits of the Company's financial statements for the prior fiscal years and through January 24, 2005, the Company has no disagreement with BLC on any matter of accounting principles or practices, financial statement disclosure or auditing scope or procedure, which disagreement, if not resolved to the satisfaction of BLC, would have caused BLC to make a reference to the subject matter of the disagreements in connection with its reports on the consolidated financial statements of the prior fiscal years and through January 25, 2005.

A letter from BLC dated January 24, 2005 is attached as Exhibit 16.1 to this Form 8-K Current Report.

(b) New Independent Certified Public Accountants

The Company's Audit Committee reviewed the qualifications of several potential applicants and chose Goldstein Lewin & Co. ("GLC") as the successor independent certified public accounting firm to be engaged effective February 1, 2005.

Prior to engaging GLC, neither the Company nor anyone acting on the Company's behalf consulted GLC regarding the application of accounting principles to a specific completed or contemplated transaction, nor the type of audit opinion that might be rendered on the Company's financial statements, and no written or oral advice was provided that was an important factor considered by the Company in reaching a decision as to any accounting, auditing or financial reporting issues.
