Item 1.01 Entry into a Material Definitive Agreement.

On September 21, 2015, Lakeland Industries, Inc.'s China subsidiary, Weifang Lakeland Safety Products Co., Ltd ("WF"), and Chinese Rural Credit Cooperative Bank ("CRCCB") completed an agreement for WF to refinance its existing line of credit with CRCCB. This refinance a loan from CRCCB to WF on the same terms in the amount of up to RMB 8,000,000 (approximately USD \$1,300,000). WF intends to draw down most of the loan amount, if not all, within a relatively short period of time. Below is a summary of the material terms of the loan facility:

o Amount of loan: RMB 8,000,000 (approximately \$1,300,000)

o Maturity Date: March 18, 2016

o Purpose of loan: Purchase of materials.

o Collateral: Inventory owned by WF

o

Interest rate of loan and calculation:

o Interest to be at 120% of the benchmark rate supplied by CRCCB (which is currently 6%).

o

Effective per annum interest rate: 5.52%;

CRCCB has hired a professional firm to supervise WF's inventory flow, which WF will pay yearly at a rate of RMB 46,000 (approximately US \$7,200).
