By reason of Rule 13d-3 under the Securities Exchange Act of 1934, as amended ("Rule 13d-3"), the General Partner may be deemed to be the beneficial owner of the securities held by the Fund.
- (3) Cora Madsen is a director of the General Partner and in this capacity has the legal power to vote or dispose of the Common Stock beneficially owned by the Fund. Therefore, by reason of Rule 13d-3 Ms. Madsen may be deemed to be the beneficial owner of securities held by the Fund. Ms. Madsen has no ownership interest, neither direct nor indirect, in the General Partner or the Fund.
- (4) Florian Schönharting is a director in Nordic Biotech Advisors ApS, which owns 100% of the shares of the General Partner and is an indirect investor in a limited partner of the Fund. As such, he may be deemed under Rule 13d-3 to be a beneficial owner of the securities held by the Fund.
- (5) Based on 231,723,931 shares of Common Stock outstanding as of October 30, 2015.
