Resignation of Principal Accounting Officer

On March 15, 2018, Jennifer Lee, the Vice President, Controller, and Principal Accounting Officer of Fluidigm Corporation ("Fluidigm" or the "Company"), notified the Company of her intention to resign, effective as of March 29, 2018.

Appointment of Principal Accounting Officer

Upon the effectiveness of Ms. Lee's resignation, Vikram Jog, our Chief Financial Officer, will serve as the Company's principal accounting officer in addition to continuing as our principal financial officer. From March 2003 to April 2005, Mr. Jog was a vice president of Applera Corporation, a life science company that is now part of Thermo Fisher Scientific, and vice president of finance for its related businesses, Celera Genomics and Celera Diagnostics. From April 2001 to March 2003, Mr. Jog was vice president of finance for Celera Diagnostics and corporate controller of Applera Corporation. Mr. Jog received a Bachelor of Commerce degree from Delhi University and an M.B.A. from Temple University. Mr. Jog is a member of the American Institute of Certified Public Accountants.

No new compensatory arrangements were entered into with Mr. Jog in connection with his appointment as Principal Accounting Officer.
