## Explanation of Responses:

- (1) The underlying Restricted Stock Units ("RSUs") were granted in a transaction exempt under Rule 16b. Upon vesting, RSUs are converted into an equivalent number of shares of Common Stock that are distributed to the grantee.  
As previously reported, on January 27, 2015, the reporting person was granted 3,088 RSUs, 1,036 of which vested on January 27, 2016 and converted into shares of common stock on such date, and 1,045 of which vested on January 27, 2017 and converted into shares of common stock on such date. Dividend equivalent rights accrue with respect to the unvested RSUs when and as dividends are paid on Hexcel common stock. The 2.17 dividend equivalent rights reflect dividend equivalent rights at \$53.08 per RSU owned by the reporting person on the record date and credited to the reporting person's account on February 15, 2017.
- (3) The underlying RSUs vest and convert into an equivalent number of shares of Common Stock in equal installments on the first three anniversaries from the grant date. Vesting of the RSUs is also subject to certain acceleration and termination provisions.  
As previously reported, on January 26, 2016, the reporting person was granted 3,376 RSUs, 1,137 of which vested on January 26, 2017 and converted into shares of common stock on such date. Dividend equivalent rights accrue with respect to the unvested RSUs when and as dividends are paid on Hexcel common stock. The 4.71 dividend equivalent rights reflect dividend equivalent rights at \$53.08 per RSU owned by the reporting person on the record date and credited to the reporting person's account on February 15, 2017.
