Following the conclusion of the three year performance period, the Compensation Committee certified to the performance of the Company relative to these goals for the 2014 PSUs at 120%.

Represents shares withheld by the Company for taxes, as permitted by the JetBlue Airways Corporation 2011 Incentive Compensation (2) Plan and related award agreement, to satisfy the tax withholding obligations of the Reporting Person in connection with the vesting and settlement of the 2014 PSUs.
