 - (1) Represents restricted stock awards effective February 26, 2019, with respect to which sale or transfer rights shall vest over three years with installments of 30% on February 26, 2020, 30% on February 26, 2021, and the remaining 40% on February 26, 2022, provided the grantee meets certain employment conditions.
