- (2) Compensation Final, as follows: (i) 25,000 of the options shall vest upon Mr. Allen's completion of one year of Board service measured from the Initial Grant date.
- (3) Mr. Allen was awarded the options in connection with his initial appointment to the QuadraMed Board of Directors.
