 - (1) Represents an award of restricted stock pursuant to a stockholder approved incentive compensation plan. Restrictions on the award lapse 100% after three years of service (July 9, 2011), or sooner, on the death, disability or retirement of the recipient, or upon a corporate change. The stock was issued on July 9, 2008, and therefore has no expiration date, but could be forfeited if service ends prior to July 9, 2011 under certain circumstances.
 - (2) Includes an aggregate of 163,130 shares of restricted stock subject to restrictions and potential forfeiture, as well as 2,569 shares of stock held in the filer's 401k plan account.
 - (3) Stock options vest in on-third increments on the first, second and third anniversaries of the grant date, subject to continued employment by the Company or a subsidiary on the applicable date. The options may vest sooner in certain events, including a corporate change. The first third will vest on July 9, 2009.
