- (1) The number of shares shown represents the time-based restricted stock units (TBRsUs) that vested and were paid on April 15, 2010. These TBRsUs were awarded on December 1, 2006.  
  
Each restricted stock unit (RSU) represents a contingent right to receive the value of one share of A. H. Belo Corporation Series A Common Stock. RSUs (both performance-related and time-based) are valued as of the date of vesting and are paid 60% in shares of A. H. Belo Corporation Series A Stock and 40% in cash.
  - (2) The number of shares shown represents settlement of the 40% cash portion of RSUs that vested and were paid on April 15, 2010. Pursuant to SEC guidance settlement of the cash portion is deemed a disposition of shares to the Company.
  - (3) The number of shares shown represents the portion of the December 2006 performance-related restricted stock units (PBRsUs) that vested and were paid on April 15, 2010. These PBRsUs were awarded in December 2006, as described below in footnote 7.
  - (4) These TBRsUs were awarded on December 1, 2006.
  - (5) These TBRsUs vest 100% and are paid as soon as practicable following the annual earnings release date for the fiscal year ended December 31, 2009.
  - (6) These PBRsUs were awarded in December 2006. The actual number of PBRsUs earned was determined on February 26, 2008.
  - (7) One-third of the original PBRsUs vest and are paid as soon as practicable following each annual earnings release date for the fiscal years ended December 31, 2007, 2008 and 2009.
