Each DSU is settled solely for one share of Common Stock upon termination of services as a Director. The grant of 1,400 DSUs is made quarterly and is fully vested at grant date.
- (2) This Form 4 amends the Form 4 filed on March 1, 2011 which incorrectly reported a grant of 4,000 options to purchase Common Stock of the Company to the reporting person. The grant of DSU shares reported in Table I of this Form represents DSU shares issued under the Third Amended and Restated ANSYS, Inc. 1996 Stock Option and Grant Plan in accordance with the 12/31/10 annual grant election of the Chairman of the Company, rather than an election by the Chairman to receive a grant of options to purchase Common Stock of the Company as initially reported.
