- (1) In lieu of receiving cash fees, the reporting person received 400 stock units, which immediately vested, in the EnerSys Voluntary Deferred Compensation Plan for Non-Employee Directors (the "Plan").

The matching stock unit contribution vests 25% on each of July 9, 2013, October 9, 2013, January 9, 2014, and April 9, 2014.
