- (1) Includes 9,281 restricted stock units (RSUs) mandatorily deferred by the Company from Mr. Harvey's annual discretionary bonus, plus 2,320 RSUs granted to Mr. Harvey as a company match on his mandatory bonus deferral. These RSUs generally will vest on the third anniversary of grant. Also includes 15,469 RSUs voluntarily deferred by Mr. Harvey from his annual discretionary bonus, plus 3,867 RSUs granted to Mr. Harvey as a company match on his voluntary bonus deferral. These RUSs generally will be delivered on the third anniversary of grant. Also includes 62,179 RSUs that vest one-fifth ratably on each of January 27, 2007, 2008, 2009, 2010 and 2011. All of these RSUs were granted pursuant to the Company's 2004 Stock Incentive Plan.
- (2) Includes 3,320 shares acquired under the Company's Employee Stock Purchase Plan through December 31, 2005. Also includes 1,328 RSUs aciuired pursuant to a dividend reinvestment feature under the Stock Incentive Plan.
