On October 22, 2004, the Registrant signed a definitive agreement to sell its majority interest in Citizens Financial Bank, Inc. to Porter Bancorp, Inc. (the "Stock Purchase Agreement"). Concurrently, with the signing of the Stock Purchase Agreement, Independence Bank, Inc., the Registrant's wholly owned subsidiary, entered into a real estate contract with Porter Bancorp's affiliate, Ascencia Bank, Inc.
