***Harmony/Gold Fields merger receives UK competition approval***

Harmony hereby announces that on 14 April 2005, it received notice from the United Kingdom Office for Fair Trading approving Harmony's proposed merger with Gold Fields.

In addition, Harmony wishes to advise that it has consented to the transfer by Norilsk of all its shares in the issued share capital of Gold Fields to an indirect wholly-owned subsidiary of Norilsk ( Subco ) and to cede all its rights and delegate all its obligations in terms of Norilsk's irrevocable undertaking to Subco.

The transfer by Norilsk of its Gold Fields shares to Subco is in accordance with its strategy to consolidate all of its gold assets into one vehicle and does not have any impact on the obligations under the irrevocable undertaking.
