**INTRODUCTORY STATEMENT**

This Amendment No. 1 to Schedule TO (this **Amendment** ) amends and supplements the Tender Offer Statement on Schedule TO-I (the **Schedule TO-I** ) filed by Amgen Inc., (the **Company** ), on January 31, 2006 related to the Liquid Yield Option Notes due 2032 (Zero Coupon Senior) (the **Securities** ). This Amendment relates to the right of each holder (the **Holder** ) of the Securities, to sell, and the obligation of the Company to purchase, the Securities, as set forth in the Company Notice to Holders of Liquid Yield Option Notes due 2032, dated January 31, 2006 (the **Company Notice** ), and the related notice materials previously filed as exhibits to the Schedule TO-I (which Company Notice and related notice materials, as amended or supplemented from time to time, collectively constitute the **Put Option** ). This Amendment amends and supplements the Schedule TO-I as set forth below.
