**Item 3.02 Unregistered Sales of Equity Securities.**

On June 9, 2009, OMNI Energy Services Corp. (the Company ) agreed to issue 233,333 shares of unregistered restricted common stock of the Company at \$1.50 per share and pay \$500,000 in cash in partial satisfaction of a promissory note originally issued on April 23, 2008 in the principal amount of \$2,000,000, thereby reducing the outstanding principal amount by \$850,000.

The Company issued the securities described under this Item 3.02 in reliance on the exemption from registration contained in Section 4(2) of the Securities Act of 1933, as amended.
