The shares to be registered hereunder are MuniFund Term Preferred Shares of beneficial interest, par value \$0.01 and \$10.00 liquidation preference per share, 2.30% Series 2015 (MTP Shares), of Nuveen Michigan Quality Income Municipal Fund (the Registrant). The description of the MTP Shares is contained in the proxy statement/prospectus and in the related exhibits included in the registration statement on Form N-14, filed by Nuveen Michigan Quality Income Municipal Fund, Inc.
