First Interstate Bank beneficially owns 8,518,100 shares of Common Stock (of which 7,150,341 shares are Class B Common Stock and 1,367,759 shares are Class A Common Stock), representing 31.5% of the Class A Common Stock and 29.4% of the Class B Common Stock. First Interstate Bank has shared voting and dispositive power over 1,263,592 shares of Class A Common Stock held as trustee for the Savings and Profit Sharing Plan of First Interstate BancSystem, Inc. In addition to shared voting and dispositive power with respect to the foregoing shares, First Interstate Bank has shared voting and dispositive power over 178,423 shares of Common (of which 2,643 are shares of Class A Stock and 175,780 are shares of Class B Stock) held as trustee for two Scott family members. First Interstate Bank also has shared dispositive power for 6,431,088 shares of Common Stock (of which 90,165 shares are Class A and 6,340,923 shares are Class B) held as trustee for eleven Scott family members, including 111,430 shares of Class B Stock for which First Interstate Bank has shared voting authority and 6,319,658 shares (of which 90,165 are shares of Class A Stock and 6,229,493 are shares of Class B Stock) for which First Interstate Bank has no voting authority. First Interstate Bank has sole dispositive power over 644,997 shares of Common Stock held as trustee for twenty-one Scott family members, including 346,556 shares (of which 5,638 are shares of Class A Stock and 340,918 are shares of Class B Stock) for which First Interstate Bank has sole voting authority and 298,441 shares (of which 5,721 are shares of Class A Stock and 292,720 are shares of Class B Stock) for which First Interstate Bank has no voting authority.
