Explanatory Note

On July 2, 2014 Atlas Resource Partners, L.P. (<u>ARP</u>) filed a Current Report on Form 8-K (the <u>Original</u> 8-K) to report the completion by ARP Rangely Production, LLC, ARP s wholly-owned subsidiary, of the previously announced acquisition (the <u>Rangely Acquisition</u>) of certain oil and gas related interests in the Rangely Field assets in northwest Colorado from Merit Management Partners I, L.P., Merit Energy Partners III, L.P. and Merit Energy Company, LLC (<u>Merit Energy</u>) for \$420.0 million in cash (the <u>Acquired Assets</u>).
