### **Canadian Pacific and Unifor reach tentative agreement**

CALGARY, AB Canadian Pacific (TSX: CP) (NYSE: CP) is pleased to announce that a tentative four-year agreement has been reached with Unifor, the union representing CP's 1,200 active mechanical employees that maintain rail cars and locomotives.

Details of the tentative agreement are being withheld pending ratification by the Unifor membership.

After months of negotiating, we have agreed on a deal that is fair to all stakeholders," E. Hunter Harrison, CP's Chief Executive Officer said. "We look forward to a successful ratification vote and to working together with our Unifor colleagues in driving CP forward."
