### Explanatory Note

On August 9, 2016, Duke Realty Corporation, an Indiana corporation (the **Company**), and Duke Realty Limited Partnership, an Indiana limited partnership (the **Operating Partnership**), of which the Company is the sole general partner, entered into an Equity Distribution Agreement (the **Equity Distribution Agreement**) with Barclays Capital Inc., BB&T Capital Markets, a division of BB&T Securities, LLC, Citigroup Global Markets Inc., J.P. Morgan Securities LLC, RBC Capital Markets, LLC, Scotia Capital (USA) Inc., and Wells Fargo Securities, LLC, as sales agents and/or principals (the **Agents**). A copy of the Equity Distribution Agreement is filed as Exhibit 1.1 to the combined Current Report on Form 8-K filed by the Company and the Operating Partnership on August 9, 2016. Under the terms of the Equity Distribution Agreement, the Company may sell shares of its common stock, \$0.01 par value per share, from time to time, to or through the Agents, up to an aggregate offering price of \$200,000,000 (the **Offering**). The shares were initially offered pursuant to the Company's shelf registration statement on Form S-3 (Registration No. 333-203744), which became effective upon filing with the Securities and Exchange Commission (the **Commission**) on April 30, 2015 (the **2015 Registration Statement**). On April 30, 2018, the Company and the Operating Partnership filed a new registration statement on Form S-3, which became effective upon filing with the Commission (the **Registration Statement**), to replace the expiring 2015 Registration Statement. Also on April 30, 2018, the Company filed a prospectus supplement pursuant to Rule 424(b)(5) related to the securities that remain unsold pursuant to the Offering. This Current Report on Form 8-K (the **Report**) is being filed to provide exhibits to be incorporated by reference into the Registration Statement.

#### **Item 9.01. Financial Statements and Exhibits.**

By filing this Report, and the exhibits hereto, however, neither the Company nor the Operating Partnership believe that any of the information set forth herein or in the exhibits hereto represent, either individually or in the aggregate, a fundamental change (as such term is used in Item 512(a)(1)(ii) of the Commission's Regulation S-K) in the information set forth in, and incorporated by reference into, the Registration Statement.
