<b>Fixed Rate Interest Payment Dates:</b>	During the Fixed Rate Period, interest will be payable semi-annually in arrear on February 15 and August 15 in each year, commencing on August 15, 2019 (long first interest period) and ending on the Par Redemption Date.
<b>Floating Rate Interest Payment Dates:</b>	During the Floating Rate Period, interest will be payable quarterly in arrear on May 15, 2022; August 15, 2022; November 15, 2022 and the Maturity Date (each a Floating Rate Interest Payment Date ).
<b>Interest Reset Dates:</b>	During the Floating Rate Period, the Floating Interest Rate will be reset quarterly on the Par Redemption Date, May 15, 2022; August 15, 2022 and November 15, 2022 (each an Interest Reset Date ). If any Interest Reset Date would fall on a day that is not a Business Day, the Interest Reset Date will be postponed to the next

succeeding Business Day, except that if that Business Day falls in the next succeeding calendar month, the Interest Reset Date will be the immediately preceding Business Day.

**Interest Periods:**

During the Floating Rate Period, each interest period on the Notes will begin on (and include) a Floating Rate Interest Payment Date and end on (but exclude) the following Floating Rate Interest Payment Date, provided that the first of such interest periods will begin on and include the Par Redemption Date and will end on, but exclude, May 15, 2022.

**Interest Determination Dates:**

The Interest Determination Date for each Interest Period will be the second London Banking Day (as defined below) preceding the applicable Interest Reset Date (as defined below). London Banking Day means any day on which dealings in U.S. dollars are transacted in the London interbank market.
