## **Novo Nordisk A/S – Share repurchase programme**

**Bagsværd, Denmark, 17 December 2012** On 9 November 2012 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission’s regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk will repurchase B shares for an amount up to DKK 1.5 billion in the period from 9 November 2012 to 29 January 2013.

Since the announcement as of 10 December 2012, the following transactions have been made under the programme:
