- Prior to the exchange, the reporting person surrendered 1,110,533 shares of common stock to the issuer. Each share of Series C Preferred Stock that the reporting person then holds that is not the subject of outstanding grants under the LTIP converts automatically into one share of common stock in the event of an acquisition of the issuer by another company or upon certain other specified events.
