The shares underlying this restricted stock award will vest in full on the earlier of (i) May 20, 2011 or (ii) the date immediately preceding the date of the issuer's 2011 annual meeting of stockholders.
- (2) In accordance with the issuer's non-employee director compensation policy, shares were issued in lieu of the quarterly cash payment of board and committee meeting attendance fees at the election of the Reporting Person.
- (3) Shares are held by the Guleri Family Trust UTD dated April 7, 1999 (the "Guleri Trust"). The Reporting Person is a trustee and beneficiary of the Guleri Trust.
