(1) This entry represents the number of shares of ViaSat, Inc. common stock withheld by the Issuer to satisfy the tax withholding obligation of the Reporting Person. These shares were not sold by the Reporting Person but were instead offset from the total number of vested shares received by the Reporting Person from the Issuer.

(2) The restricted stock unit was granted to Steven Hart, an employee of ViaSat, Inc. Upon vesting the shares were contributed to The Hart Family Trust.

(3) Includes 177 shares of common stock the reporting person acquired under the ViaSat 401(k)Plan, since the date of the reporting person's last ownership report.

(4) The original restricted stock unit grant was for 14,333 restricted stock units on 11/12/2012.
