- (1) Reflects withdrawal of shares from the Wesley GST Exempt Trust, which Mr. Wesley previously established for the benefit of his heirs. On the same date, Mr. Wesley donated the shares of the issuer's common stock to a charitable fund in which he has no pecuniary interest.
