All grants are subject to the Reporting Person's continued employment with Workday on the applicable vesting dates.

This option grant will be exercisable in full or in part at any time, but the unvested portion is subject to the Issuer's right to repurchase the shares at the original exercise price in the event of termination of the Reporting Person's service for any reason.
