These restricted stock units are granted pursuant to the Issuer's 2011 Equity Incentive Plan. Each restricted stock unit represents a (1) contingent right to receive one ordinary share upon the vesting of the unit. These units vest in four equal annual installments on the anniversary of the grant date, February 26, 2015.

(2) Includes 472 ordinary shares in the aggregate acquired under a Section 423 Employee Stock Purchase Plan on May 30, 2014 and November 28, 2014.

(3) Shares withheld to satisfy tax obligations arising out of vesting of a portion of previously granted restricted stock units.

These two options are granted pursuant to the Issuer's 2011 Equity Incentive Plan. The ordinary shares subject to these two options vest (4) over four years measured from the grant date, February 26, 2015, with 1/4th vesting on the first anniversary of the grant date and the remainder vesting in 36 equal monthly installments thereafter.
