- (1) As a result of the merger of Spyglass Merger Corp. with and into the Issuer, the option thereafter became exercisable, after payment of the exercise price, for \$24.00 per share in cash, without interest.  
  
Prior to 3/10/06, such option would become vested and exercisable with respect to 1/4 of the shares underlying such option on 4/14/04 and would become vested and exercisable with respect to the remaining shares underlying such option in equal installments on each one-month anniversary of 4/14/04 until 4/14/07, at which time such option would be fully vested and exercisable. Immediately prior to the effective time of the merger of Spyglass Merger Corp. with and into the Issuer, the option became fully vested and exercisable with respect to all shares underlying such option that were not previously vested and exercisable.
