- (1) Between July 28, 2005 and October 2, 2005, the Reporting Person acquired 12 shares of DRE stock through dividend reinvestment.
- (2) The Stock Options were fully vested on the grant date.
- (3) The Stock Options vested annually at a rate of 20% per year and were fully vested on 1/25/05.
- (4) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/31/06.
- (5) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/30/07.
- (6) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/29/08.
- (7) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/28/09.

(8) Represents phantom stock units accrued under the Directors' Deferred Compensation Plan of Duke Realty Corporation. Between July 28, 2005 and October 2, 2005, the Reporting Person acquired 172 phantom stock units through dividend reinvestment. The units are valued on a one to one basis to the Company's common stock and are to be settled in cash and stock upon the Reporting Person's termination as a director of the Issuer.

(9) Represents shares issued through the 2005 Non-Employee Directors Compensation Plan.

(10) Represents phantom stock units accrued under the Weeks Corporation 1998 Deferred Compensation Plan. Between July 28, 2005 and October 2, 2005, the Reporting Person acquired 26 phantom stock units through dividend reinvestment. All amounts accrued under the plan are to be paid in cash upon the Reporting Person's termination as a director of the Issuer.
