- (1) Between July 6, 2006 and October 3, 2006, the Reporting Person acquired 27 shares of DRE common stock through dividend reinvestment.
- (2) Securities and Options held by the Charles Roy Eitel Revocable Trust in which the Reporting Person is the grantor.
- (3) The Stock Options vested annually at a rate of 20% per year and were fully vested on 1/25/05.
- (4) The Stock Options vested annually at a rate of 20% per year and were fully vested on 1/31/06.
- (5) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/30/07.
- (6) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/29/08.
- (7) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/28/09.

(8) Represents phantom stock units accrued under the Director's Deferred Compensation Plan of Duke Realty Corporation. Between July 6, 2006 and October 3, 2006, the Reporting Person acquired 156 phantom stock units through dividend reinvestment. The units are valued on a one to one basis to the Company's common stock and are to be settled in cash and stock upon the Reporting Person's termination as a director of the Issuer.
