- (1) Between November 23, 2006 and December 14, 2006, the Reporting Person acquired 77 shares of the Company's common stock through dividend reinvestment and 113 shares through the Company's Employee Stock Purchase Plan.
 - (2) Between November 23, 2006 and December 14, 2006, the Reporting Person acquired 53 shares of DRE's common stock under the Company's 401(k) plan.

 - (8) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 2/10/11.
 - (9) Represents phantom stock units accrued under the Executives' Deferred Compensation Plan of Duke Realty Services Limited Partnership. The units are valued on a one to one basis to the Company's common stock and are to be settled in cash upon the Reporting Person termination of employment.
 - (10) Represents phantom stock units vested under the 2000 Performance Share Plan of Duke Realty Corporation. Between November 23, 2006 and December 14, 2006, the Reporting Person acquired 80 phantom stock units through dividend reinvestment. The units are valued on a one to one basis to the Company's common stock and are to be settled in cash upon the Reporting Person's termination of employment.
