Options to purchase 347,000 shares of common stock are exercisable at prices ranging from \$.23 to \$1.95 per share, vest immediately (1) upon grant and have a term of 10 years from date of grant. The remaining 726,500 options are exercisable at prices ranging from \$.33 to \$1.80 per share, vest equally over a 5 year term from date of grant and have a 10 year term.
