**GOL ANNOUNCES PERIOD FOR RECONSIDERATION  
OF SHARE SUBSCRIPTION**

**São Paulo, May 30, 2007** GOL Linhas Aéreas Inteligentes (NYSE: GOL and Bovespa: GOLL4), Brazil's low-cost, low-fare airline, informs its shareholders pursuant to Instruction No. 358/02 of the Brazilian Securities Commission (CVM), that 6,083,212 preferred shares were subscribed and paid for in the Company's preemptive rights offering.

Because not all preferred shares offered in the preemptive rights offering were subscribed for, and as resolved by the Board of Directors of GOL, the capital increase with regard to the preemptive rights offering shall only be partially ratified in the amount of shares subscribed for in the offering. In view of this resolution, GOL is required under the applicable Brazilian regulations to grant to its shareholders the possibility to reconsider the subscription of any shares subscribed. This opportunity is not granted to holders of our American Depositary Receipts (ADRs) that have subscribed for ADRs in the preemptive rights offering.

According to CVM order CVM/SEP/GEA-4 No. 166/2007 of May 28th, 2007, the common and preferred shareholders will have the period of ten days, counted from the date of this release, to reconsider their decision to subscribe for our preferred shares in the preemptive rights offering. After such period, the Board of Directors will partially ratify the capital increase, and the preferred shares and ADRs effectively subscribed will be issued on or about June 15, 2007.
