**MATERIAL FACT**

Companhia de Saneamento Básico do Estado de São Paulo Sabesp, pursuant to CVM Rule 358, as of January 3, 2002, and amendments, publicly announces to its shareholders and the market in general that on August 11, 2010, the São Paulo State Sanitation and Energy Regulatory Agency (ARSESP) approved the tariff readjustment index of four point zero five percent (4.05%) to be applied over water and sewage tariffs as of September 11, 2010. This index was published on Diário Oficial do Estado Newspaper (D.O.E.) on August 13, 2010.

The aforementioned readjustment is not applicable to the municipalities of São Bernardo do Campo, Lins and Magda which are governed by different rules.

Upon the readjustment effectiveness, tariff charts will be available on Sabesp website, [www.sabesp.com.br](http://www.sabesp.com.br), and at all the Company's customer service offices.
