## RESOLUTIONS OF THE EXTRAORDINARY GENERAL MEETING

Rio de Janeiro, April 4<sup>th</sup> 2011, Petróleo Brasileiro S.A. - Petrobras informs the Extraordinary General Meeting was held today, at 3 p.m., in the auditorium of the Company's head office building at Av. República do Chile, nº 65, 1st floor, in the City of Rio de Janeiro (RJ), approved the following items:

I. Change in the wording of the caput of Article 20 of the Company's bylaws, by excluding the word "up to", and establishing the number of Directors.

II. Merger of Companhia Mexilhão do Brasil to Petrobras in order to:

(1) Approve the Merger and Justification Protocol signed between the directors of Companhia Mexilhão do Brasil and Petrobras on February 14, 2011;

(2) Ratify the hiring of KPMG Auditores Independentes by Petrobras to elaborate the Appraisal Report of Companhia Mexilhão do Brasil, pursuant to paragraph 1 of Article 227 of Law No. 6.404/76;

(3) Approve the Appraisal Report elaborated by KPMG Auditores Independentes at book value, for appraisal to the stockholders' equity of Companhia Mexilhão do Brasil;

(4) Approve the merger of Companhia Mexilhão do Brasil to Petrobras, with no increase in its capital stock; and

(5) Approve the authorization granted by PETROBRAS' Board of Directors to perform all acts required to the merger and regularization of the status of the merged and merger companies before the competent bodies, as required.
