#### ITEM 6. OWNERSHIP OF MORE THAN FIVE PERCENT ON BEHALF OF ANOTHER PERSON

First Eagle Investment Management, LLC (FEIM) (Formerly known as Arnhold and S. Bleichroeder Advisers, LLC), an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is deemed to be the beneficial owner of 6,135,731 shares (assuming the conversion of convertible bonds into 68,827 shares of the Issuer's common stock), or 7.71% of the Common Stock believed to be outstanding (assuming conversion of the convertible bonds noted above) as a result of acting as investment adviser to various clients. Clients of FEIM have the right to receive and the ultimate power to direct the receipt of dividends from, or the proceeds of the sale of, such securities. The First Eagle Global Fund, a registered investment Company for which FEIM acts as investment adviser, may be deemed to beneficially own 5,275,011 of these 6,135,731 shares, or 6.64% of the Company's Common Stock.
